THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION

Automatically self-righting liferaft type KHZ-100 with brand names YOULONG, SEA SAFE, HERO

Max. number of persons: 100

Weight: 765 kg with SOLAS A PACK and 565 kg with SOLAS B PACK

Required bollard pull:

at 2 kn / 2,1 kN

at 3 kn / 2,9 kN

2. APPLICATION/LIMITATION OF USE

Maximum stowage height: 25 m

The liferaft and container shall be marked with name of manufacturer, serial number, date of manufacture and all other markings in accordance with LSA Code item 4.2.6.3 and 4.2.7.

The liferaft shall be packed with a SOLAS A PACK or SOLAS B PACK.

Liferaft is intended to be installed with external weak link and a hydrostatic release unit.

3. DESIGN DRAWINGS AND SPECIFICATIONS

5. MATERIALS OR COMPONENTS REQUIRED TO BE TYPE APPROVED OR TYPE TESTED

Hydrostatic release unit shall comply with the requirements of MED 2014/90 EU.

6. OTHER MATERIALS AND/OR COMPONENT

Gas cylinders shall be of an approved type.

Components in the gas inflation system should be approved according to ISO 15738:2002.

7. PRODUCTION SURVEY REQUIREMENTS

The manufacturer is allowed to affix the Mark of Conformity to equipment referred and to issue a Declaration of Conformity as long as either of the following is fulfilled:

Module D: The quality system for production and testing shall be approved by the Notified Body, or

Module E: The quality system for inspection and testing shall be approved by the Notified Body, or

Module F: Compliance of the products in this EC Type-Examination Certificate is to be verified by the Notified Body, who shall also issue a Certificate of Conformity.

Production testing shall be carried out according to IMO Res. MSC 81(70) Part 2.

8. ONBOARD INSTALLATION AND MAINTENANCE REQUIREMENTS

Installation shall be performed according to manufacturer's instruction.

Float free arrangement to be checked upon installation onboard.

The liferafts are to be serviced annually at approved service stations which are authorised by the manufacturer.

9. MARKING AND IDENTIFICATION



Subject to compliance with the conditions in this Schedule of Approval which forms part of certificate, and those of Articles 9, 10 and 15 of the Directive, the Manufacturer is allowed to affix the "Mark of Conformity" to the Product described herein.
