DETAILED PRODUCT DESCRIPTION:

Plutajući ponton tip FE/CF/12RR-3/3.00 (FE/CF/8RR-3/3.00) ima čeličnu strukturu (EN 10025 S275 JR) zavarenu MAG postupkom zaštićenu metodom toplog pocinčavanja. Paluba od tropskog drva Yellow Ballau postavljena je na uzdužnim aluminijским nosačima (EN-AW 6060-T6). Ponton ima 3 (2) uzgonska elementa dimenzija 2,92x2,0x0,9 m izrađena od ekspanđiranog polistirena klase SD, tipa N presvučenog s tankim slojem betona C20/25 ojačanog polipropilenskim vlaknima.

Floating pontoon type FE/CF/12RR-3/3.00 (FE/CF/8RR-3/3.00) structure is made of steel (EN 10025 S275 JR, MAG welded and hot-dip galvanized). Deck is made of tropical wood Yellow Ballau screwed on aluminium beams (EN-AW 6060-T6). Pontoon has 3(2) floating units with dimensions 2.92x2.0x0.9 m made of expanded polystyrene grade SD, type N covered with thin layer of C20/25 sulphate resistant concrete reinforced with polypropylene fibres.
